We are committed to protecting your privacy and this page outlines our policy concerning your personal information. By using the jetcs.co websites and any of its subdomains, you accept the practices described in this Privacy Policy. We comply with the principles of the EU Data Protection Directive (EU 95/46) and other regional equivalents and aim to maintain consistently high levels of best practices in processing your personal data.

JETCARDS ("we", "our", "us") are committed to protecting and respecting your privacy. This Policy explains how we use the information we collect about you and how you can instruct us if you prefer to limit the use of that information. Please read the following carefully to fully understand our practices regarding personal data. By submitting personal data on registration to www.jetcs.co or any of our affiliated websites (the "sites") you consent to the collection, storage, use, and disclosure of such personal data in accordance with the provisions of this Policy. The sites are operated by us.

What information do we collect?

We may collect and process the following data about you:

Information that you provide by filling in forms, specifically, but not exclusively any registration form, on our sites. This

includes information provided at the time of subscribing to a service provided by us, purchasing items through our sites, posting material on or to our sites (where permitted), requesting further services, or utilizing any future services we may offer. Information may also be requested when you enter a competition or promotion sponsored by us or another company in our group of companies, and when you report a problem with our sites;

Details of your visits to our sites (including, but not limited to, traffic data, location data, weblogs, and other communication data, whether this is required for our own billing purposes or otherwise) and the resources that you access;

Such other data or information emailed by you to us or entered by you on our sites.

Uses made of the information

We use information held about you in the following ways:

To enable us to supply you with further information about our company, products, and/or services that you request from us or which we feel may interest you where you have consented to be contacted for such purposes;

To ensure that content from our sites is presented in the most effective manner for you and for your computer;

To aid us in providing you with assistance where you have requested services and products, further information, or logged an enquiry;

To carry out our obligations arising from any contracts entered into between you and us. To the extent that carrying out such obligations necessitates us disclosing your personal information to agents, contractors or other third parties involved in the performance of contracts entered into between you and us, you agree and consent to such disclosure;

To allow you to participate in interactive features of our service when you choose to do so; To notify you about changes to our services;

In order to comply with any of our legal and regulatory obligations;

To monitor website usage in order to improve our services and sites.

You will not receive unsolicited marketing communications from us unless you have agreed to this. We may, however, contact you from time to time as necessary with information or queries about your registration, your purchases and/or your postings.

We may disclose your personal information to any member of our group, which means our subsidiaries, our ultimate holding company, and its subsidiaries.

We may disclose your personal information in the following circumstances:

In the event that we sell or buy any business (in whole or in part) or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets and may sell and transfer personal data collected

through the site in connection with and pursuant to the sale of any such business or assets;

If we or substantially all of our assets are acquired by a third party, in which case personal data held by us about our customers will be one of the transferred assets;

To the extent necessary to enable us to carry out our obligations arising from any contracts entered into between you and us;

If we are under a duty to disclose or share your personal data in order to comply with any legal obligation; to operate our systems properly; or to protect our rights, property, or safety, our subsidiaries, affiliates, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction; and

To trusted third parties who assist us in operating the sites, conducting our business, or servicing you, so long as those parties agree to keep this information confidential.

How do we protect your information?

We take our data security responsibilities seriously, employing the most appropriate physical and technical measures, and review these measures regularly. We follow strict security procedures in the storage and disclosure of customer information. All sensitive credit information is transmitted via Secure Socket Layer (SSL) technology. SSL is the industry-standard method of encrypting personal information and credit/debit card details so that they can be securely transferred over the internet.

In accordance with the above, we will take appropriate security measures to guard against unauthorized access to your personal data or against its alteration, disclosure, or destruction. However, the transmission of information via the

internet is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to our sites; any transmission is therefore at your own risk.
